With reference to the subject and letter cited above, I am to inform that the proposal mentioned under subject above has been received in the Regional Office, Shillong seeking prior approval of the Central Government in accordance with Section 2 of the FCA, 1980 from the State Govt of Assam vide letter under reference above. The proposal was forwarded to Ministry, New Delhi by Regional Office, Shillong vide letter No. 3-AS B 031/2017-SHI/1976 dated 19.09.2017 for approval of the competent authority as the proposed area is for mining. The original proposal was returned from the Ministry vide letter F.No. 14-10/2018-ROHQ dated 16.04.2018.

In view of the Ministry's letter dated 16.04.2018 mentioned above, I am directed to inform that the proposal for diversion of 1.0 hectare of forest land for operation of Tokrabandha Hill Stone Quarry No.9 under Dhubri Division in favour of Sri Mobarak Hussain, Dhubri is rejected as the proposed area is near to the natural water source and the Assam Govt had withdrawn the proposal vide Secretary, Govt of Assam's letter No FRS.226/2017/29 dated 27.02.2018 and Principal Chief Conservator of Forests Assam's letter No. FG.27/Nodal/Mahal Proposal (New) Genl./Pt-II dated 17.02.2018. Therefore, the proposal in original is returned

herewith and this instant proposal is therefore closed and deleted from the pending list of the Regional Office, Shillong.
