- 2- User Agency/DFO का Checklist पर हस्ताक्षर नहीं है। अतः Checklist पर हस्ताक्षर कर as additional Information के रूप में upload किया जाय तथा उसकी 08 प्रति इस कार्यालय को भेजी जाय।
- 3- Tree enumeration की संख्या Specific Recommendation में 90,228 है, जबकि Part-II में 91,564 है, ऐसा क्यों?
- 4- 09-05-2022 के निरीक्षण में पाया गया कि कुछ जगह पर Trees में Marking No. नहीं है। प्रस्तावित स्थल पर साल का काफी Coppicing/Regeneration देखा गया, लेकिन 0-30cm girth class में मात्र 1326 संख्या है। ऐसा क्यों है?

उपरोक्त अनुपालन प्रतिवेदन यथाशीघ्र समर्पित करें ताकि इसमें अग्रेत्तर कार्रवाई की जा सके।
