With reference to the subject and letter cited above, I am to inform that State Govt letter under reference above has been examined in this office and information submitted are found incomplete. State Govt is therefore requested to kindly furnish the following information to this office for further processing of this proposal:-

- State Govt is to clarify whether any forest clearance has been granted for the existing road from Papu Nallah to Banderdewa Road (40.40 km to 59.17 km), if not reason is to be submitted.
- The specific comment of the Chief Wildlife Warden on the distance of the proposed area from Itanagar Wildlife Sanctuary. In case if the proposed area is within the Sanctuary than NBWL clearance may be submitted.
- The specific comment of the Chief Wildlife Warden as the proposed four laning passes through Elephant Corridor.
- The legal status of the proposed muck dumping site 7.005 ha, as it is mentioned as "Private land" as per the joint verification report of Range Officer, Banderdewa Forest Range whereas in the submitted SoI map it is mentioned as "MDA of package (B&C) Falls under Drupong RF".
- State Govt to furnish the enclosure Annexure 'VI' in respect of diagrammatic sketch of road showing drain, number of culvert etc. as mentioned in the State Govt letter under reference above as the same is not found enclosed.

Sir,

Please refer to the State Government's letter No. FOR. 5-64/CONS/2018/2243-47 dated 03.09.2020 on the subject mentioned above, seeking prior approval of the Central Government in accordance with Section 2 of the FCA, 1980. The proposal forwarded by the State Govt has been examined in this office in the light of Forest (Conservation) Act, 1980, and rules/guidelines framed thereunder. The State Govt. is requested to provide following additional information for further processing of the case: -

1. The Cost Benefit Analysis is to be submitted as per the new Guidelines of MoEF & CC dated 01.08.2017.
2. Trees involved is shown as 854 nos in the forwarding letter, whereas in the site inspection report of DFO and enumeration list given 2061 nos. This difference may be clarified by State Govt.
3. Comments from CWLW as the proposed four laming passes through Elephant corridor.
4. Status of FRA and Form -I under FRA for linear projects may be submitted.
5. The road improvement is from 40.400 km to km 59.170 km, whereas remaining stretch has not mentioned in the proposal submitted. State Govt may clarify the improvement in 40.400 km to km 59.170 km only.
6. Muck dumping mentioned to be in Private land, whereas in maps submitted shown as 7.005 ha MDA; hence GPS co-ordinates may be furnished.
7. Certificate for additional NPV, if any required.
8. Status of Wildlife clearance, as proposal mentions that it is within 300 mtr to 500 mtrs from Itanagar Wildlife Sanctuary.
9. Diagrammatic sketch of road showing drain, number of culvert etc. If any bridge is to be constructed, the diagram of bridge etc. in details.
10. The State Govt to re-examine the CA scheme for item at sl. no. 14 for construction of modified improved standard size Barcha (MB) type quarter and item at sl. no. 15 for construction of OBT labourer shed as such items are normally not part of CA estimate and this could be prepared from NPV amount.
