The proposal was discussed in the REC meeting held on 19.08.2022 and as per Ministry's letter No.FC-7/43/2020-FC dated 22.03.2022, the proposal file was submitted to the Ministry on 24.09.2022 for consideration. The Ministry has returned the file with the following observation:

1) Issue related to violation needs to be examined hostically in context of 42 cases mentioned by the NGT in its order dated 26.04.2022 in OA No.29/2019/EZ.

2) Complete detail of action taken by the authorities in the State and by the after IRO after cognizance of the reported violation of the Forest (Conservation) Act, 1980.

Further, this office vide letter dated 02.09.2022 has requested the State Govt. to furnish the name & designation of officials responsible for violation of FC Act, 1980 along with complete details of action taken by the State Govt. against the erring officials, which is still awaited.
