Diversion of 1.3463 ha of forest land in favour of Jal Shakti Vibhag, for the construction of Source Level Augmentation of WSS/ LWSS by providing LWSS from Govind Sagar Lake at Kut Bounger, within the jurisdiction of Bilaspur Forest Division, Distt. Bilaspur, Himaachal Pradesh. (Online Proposal No. FP/HP/Water/118984/2021)

महोदय,

उपरोक्त विषय पर संदर्भित पत्र का आशय ग्रहण करते हुए सूचित करना है कि प्रस्ताव पर ध्यानपूर्वक विचार करने के उपरांत अभी भी राज्य सरकार से निम्नलिखित बिन्दुओं पर सूचनाएं अपेक्षित हैं। अतः राज्य सरकार चाही गई सूचनाएं प्रेषित करने का कष्ट करें, ताकि प्रस्ताव पर आगामी कार्यवाही सुनिश्चित की जा सके :-

1. The component marked on the revised Layout Plan are not matching with the Part-I, Para B 2.4 neither shows the dimension of proposed pipe line segments. Further, the name of the components written on the Layout Plan are not legible. Therefore, State Govt. may provide the revised Layout Plan as per Part-I , Para B 2.4 along with the dimension of the proposed pipe line segments, duly authenticated by DFO and same may be uploaded on PARIVESH Portal.
2. Layout Plan shows that the proposed water pipe line is crossing the Sheer Khad at one place and MDR at many places. Therefore, State Govt. may provide the safety measure plan to be adopted for the same and may provide the NoC issued by the competent authority of HPPWD, regarding crossing the pine line at MDR.
3. The NPV rate has been revised by the MoEFF & CC on dated 6.1.2022. Therefore, State Govt. may submit/upload the revised NPV calculation sheet for the same.
4. Submitted Administrative Approval letter is not a legible. Therefore, state Govt. may provide/upload the same in legible form.

5. As per the forwarding letter, it is mentioned that revised Layout Plan showing water distribution system has been uploaded online Part-I, but Layout Plan neither revised nor uploaded on online portal. Therefore, State Govt. may upload the KML file of revised Layout plan on PARIVESH Portal.
6. Reclamation Plan of dumping site and the detail of measurement of muck generated from the project are not provided with the proposal. State Govt. may provide the same.
7. As per the DSS report, the proposed project site or diversion area (DA) polygon is touching the Protected Area of Gobind Sagar Wildlife Sanctuary. Therefore, the exact aerial distance of proposed DA from the Gobind Sagar Wildlife Sanctuary and its notified ESZ may be provided. Comments from the CWLW is also required, if the DA is falling within the boundary of 10 Km from the Protected Area/notified ESZ.
8. According to the State Govt. forwarding letter, it is mentioned that the land coming under the water distribution system is not included in the diversion area. Therefore, State Govt. may clarify whether the said land area is forest land or not.
