Madam/Sir,

I am directed to refer to the APCCF (LM)-cum-Nodal Officer, Government of Madhya Pradesh's letter no. F-3/50/2019/10-11/6/2326 dated 29.04.2024 on the above mentioned subject. In this regard, the Ministry vide letter of even no. dated 24.11.2023 and letter of even no. dated 22.02.2024 requested to submit the complete layout plan and wildlife management plan duly incorporating the comments of the Govt. of Uttar Pradesh for further consideration of the proposal.

However, the layout plan and wildlife management plan as submitted by the State/User Agency is again without approval of competent authorities and without incorporating the comments of the Govt. of Uttar Pradesh.

Further, the letter dated 18.04.2024 submitted by the state is written by the CWLW Uttar Pradesh to their State govt. In this regard, the final opinion/comments of the State Govt of Uttar Pradesh may be obtained and incorporated in the Wildlife Management Plan. Moreover, the CWLW Uttar Pradesh in his comments has also mentioned about a study to be carried out and the constitution of a high level committee, which may also be kept in view while formulating the wildlife management plan.

In view of the above, the State Government is once again requested to submit the approved copy of complete layout plan and wildlife management plan duly incorporating and considering the comments/concerns of the Govt. of Uttar Pradesh.
