Subject: Diversion of 2.8573 ha of Forest land for the construction of Tranh-Charoli SHP -2 MW in favour of Hydro More Power Pvt. Ltd. within the jurisdiction of Chopal Forest Division. Proposal No. FP/HP/HYD/26220/2017.

Please refer to your office memo. No. FCA/922/CF dated 20.03.2021 on the subject cited above.

During examination/ scrutiny of the proposal received vide above quoted reference following shortcomings have been noticed:-

- OA 1. Employment likely to be generated & the cost of project uploaded and recorded in the proposal folder do not tally.
- OA 2. Total area required for diversion is 02.09858 ha as per the joint inspection report and FRA certificate. But in the non availability of non forest land certificate and other documents as well as in the online portal the same is recorded 02.8573. This discrepancy needs to be corrected/ clarified.
- OA 3. Similarly as per point No. 2 non forest land required for diversion is 1.412 ha whereas the same is recorded 1.5406 ha in the check list No. 7. This discrepancy needs to be corrected/ clarified.
- DFO 4. Details of trees uploaded is not commensurating with the abstract placed in the proposal folder. Further general abstract of trees placed in the proposal folder is class wise whereas it should be girth wise as is uploaded on the MoEF Portal.
- DFO 5. Working Plan prescription of the area proposed for diversion is not found uploaded.
- OA 6. References have not been given in the hard copy of Part-I and Part II.
- DFO 7. Legal status of forest land, density of vegetation and distance of proposed site from boundary of forest are not found recorded in the hard copy of Part-II.

DFD Eco class Vth has been found recorded in the NPV bill placed in the proposal folder at page 74 whereas Eco class VIth is found uploaded online. Please correct the same.

DFD The enumeration of trees has been done during 2016. Fresh enumeration is to be done and list placed accordingly.


uA 10. Page No 117 to 132 is missing in the duplicate file.
