
Please refer to your reply of EDS submitted on PARIVESH Portal on 20-5-2023 on the subject cited above.

2. The following shortcomings are still not been attended which may be attended in all respect:-

1. The area as asked by GoI in point No. 1 & 2 has still not been revised.
2. In point No. 5, the component area required to be mentioned separately, which may be mentioned as proposed, further, the comments on RoW has not been given and it may be informed whether the trees comings under the RoW has been added in the proposal or otherwise.
3. The Para-II, Para-I (iv) as asked in point No. 6 has still not been revised.
4. In reply to point No. 7, it has been mentioned that there is no protection Working circle involved in the proposal whereas, as per the column No. 5 of Part-II, area falls under Protection working circle, hence, necessary clarification in this regard be given.
5. N reply to point No. 8, GoI has asked to clarify whether proposed project is outside or inside the boundary of Dhauladhar WLS as well as its notified ESZ, but nothing has been mentioned in this regard.
6. In reply to point No. 11, the revised plantation scheme is required to be uploaded against the appropriate column and old scheme along with other irrelevant documents are required to be replaced from the part-I and part-II.
7. In reply to point No. 12, 13, 15, 19, the documents stated to have been uploaded with reply but same should be uploaded separately on portal against the additional information detail. Further, the old/ irrelavent documents are required to be removed from the portal so that relevant documents could be accessed easily.
8. In reply to point No. 14, point wise reply is required to be given and revelent documents are required to be uploaded separately on the portal.

9. The bill of NPV has not been found uploaded online same may be uploaded and old bill may be replaced.
10. In reply to point No. 16, the density as mentioned is not matching with the density mentioned in Part-II.
11. In reply to point No. 17, the detail comments regard power evacuation plan are required to be uploaded online separately.
12. In reply to point No. 18, the necessary email stated to have been sent, but point wise reply is required to be uploaded online portal and revelent documents are required to be uploaded separately.
13. GoI has asked to provide the complete proposed project folder file in CD as PDF foremat, further, undertaking has not been found uploaded online.

You are, therefore, once again requested to ensure the proper scrutiny of each observation as raised by GoI and upload the requisite document online **by mentioning the reference of uploaded document (i.e. Sr. No., column No. & Part)** in forwarding memorandum.
