It is informed that, the proposal received in the reference 3<sup>rd</sup> cited for diversion of 1.06 ha forest land for Laying and maintaining of 33 KV line (by EPDCL) beside Narsipatnam - Tuni Road from Thandava Junction to Gandhi Nagar in favour of DEE, APEPDCL, Narsipatnam has been examined. On verification of the proposal through PARIVESH portal, the following shortcomings are noticed.

1. Against -13 (i), of Part -II in PARIVESH portal, the Divisional Forest Officer, Anakapalli has uploaded wrong kml file of the degraded forest land identified for compensatory afforestation purpose.
2. The uploaded CA scheme needs to be signed by the Divisional Forest Officer and then to be uploaded along with site inspection report of Degraded Forest Land, land suitability certificate.

In this regard, the Chief Conservator of Forests, Visakhapatnam is requested to issue necessary instructions to the concerned Divisional Forest Officer to attend the above shortcomings and submit rectified proposal for taking further action in the matter.
