Details of compensatory afforestation scheme (i) Uploaded KML file of patch (iii) Scanned copy of the geo referenced map of the proposed CA land	 Provided GPS readings do not overlap with corresponding corners of KML Polygon. There is a large mismatch between the two. The CA Polygon is not correctly overlaid on Village Map. As a result, only the Sy No. 143 & 147 of Seebi village is shown to be included. However, correct superimposition reveals that the proposed CA land encompasses parts of Sy No. 143, 146 & 147 of Seebi village, if KML file is correct.

	 Please ensure that – All corners of KML polygon and corresponding GPS readings match correctly. CA land polygon is correctly laid on Village Map and the Survey numbers are correctly mentioned.
Item 13 (iv) – Copy of Survey of India Topo sheet (1:50000) indicating boundary of proposed CA land	A blurred Topo Map on 1:10,000 scale without mentioning the Topo Sheet number is uploaded. Please upload a clear
