**Subject: Diversion of 6.86 ha of forest land in favor of Public Works Department, Sawai Madhopur for widening, strengthening and reconstruction of Sawai Madhopur-Shivpuri road (SH 30) km 82/700 to 93/390 at Tehsil and District Sway Madhopur with felling of 166 nos of trees-reg.**

Sir,

In reference to your above mentioned letter where approval for above referred forest land diversion proposal was sought; I have been directed to convey following shortcomings of the proposal for necessary rectification:

1. As per the information provided at A-3(xvii) regarding copy of documents in support of the competence/authority of the person making this application on behalf of the User Agency, the signature of authorised signatory has not been attested.
2. As per information provided at B 1 (2), (3), (4) & (5) approval in principle of other proposals were accorded in early 2016 but final approval in all these cases is still pending. Reasons for delay need submission.
3. In the Geo Referenced map uploaded with the proposal at C (iv) part I, the geo coordinates of some of the key points which defines the proposed forest land for diversion has not been provided.
4. Information at E (iii) of part I regarding temporary employment generation is incorrect. The project is having outlay of approx Rs 50 crores which is generating employment of the tune of 50 man days.
5. The cost of proposal mentioned in part I does not match with the project cost mentioned in DPR uploaded with the proposal.
6. The certificate for site suitability of Compensatory Afforestation is not available with the proposal and in part II (online) at Sr no. 13 (vi) the same is showing "403 - Forbidden: Access is denied forbidden".
7. The compensatory afforestation scheme is sketchy without details regarding SMC works, protection of CA, cost escalation due to inflation etc. The same needs revision.

8. As per GIS DSS analysis of NFL chosen for proposed compensatory afforestation, the extent of the area is 2.369 ha. As per FCA guidelines equivalent non forest land (NFL) shall be proposed in lieu of proposed forest land diversion. This anomaly needs rectification.
9. The site inspection reports of the concerned DCF and CCF does not mention legal status of forest land.
10. CD containing kml files for proposed forest land for diversion and proposed compensatory afforestation has not been provided with the hard copy of the proposal.

Therefore, the proposal is hereby placed under EDS category for rectification/revision of the same as per the observations made above in point wise manner.
