Sub : Proposal for diversion of 5.0 ha of forest land for quarrying of sandstone /road meal at Murum and Shally Earth in favour of M/s Sanjit Stone Mining and Crusher at Long Koireng, Kangpokpi District, Manipur-reg.

Sir,

In inviting a reference to the subject and letter cited above, I am to inform that this instant proposal for diversion of 5.0 ha of forest land for quarrying of stone/road metal at Murum and Shally Earth in favour of M/s Sanjit Stone Mining and Crusher at Long Koireng, Kangpokpi District was received back in IRO, Shillong from Ministry of Env., Forest & Climate Change, New Delhi, where Ministry desired additional information on the following:

- 1) The physical and financial target for compensatory afforestation scheme submitted over an area of 10.0 ha at the cost of Rs.14.552 lakh and 0.404 ha at the cost of Rs.0.3911 lakh with maintenance period of only 8 years; whereas the maintenance period should be for 10 years. The same may be revised/ corrected accordingly.
- 2) Purpose wise breakup for proposed diversion of 5.0 Ha i.e. for mining and safety zone.
- 3) The KML/Shape file for proposed diversion area showing the mining area & safety zone along with the KML/Shape file for compensatory afforestation area to be uploaded in PARIVESH portal.

In view of the above, the desired information may be submitted at the earliest so as to enable this office for taking further necessary action.
