

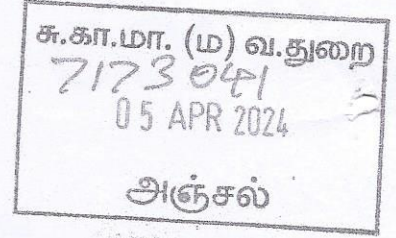

It is, therefore, requested to kindly clarify why the forest area required for reconstruction of minor bridge proposal is not included in the diversion proposal.
