Sir,

With reference to the subject and letter cited above, I am directed to inform that the State Govt letter under reference (i) above has been examined in this office and following lacking information are observed:-

1. The proposed area for the foot track from Tappa to Goying (0.00 Km to 18.60 Km) is 10.30 ha (i.e., 9.3 ha foot track and 1 ha for muck disposal area). However, now State Govt letter under reference (i) above submitted that the area identified for muck dumping location is 0.75 ha instead of earlier proposed muck dumping area i.e., 1 ha.

2. State Govt is to clarify on the difference of 0.25 ha area in the proposed foot track from Tappa to Goying, in case any change is proposed area, a revise proposal is to be submitted.
3. The original or colour scanned SoI toposheet indicating the proposed foot track and muck dumping sites (5 Nos.) along with GPS coordinates.
4. The muck dumping plan approved by the concerned DFO.
5. To upload State Govt EDS reply letter under reference (i) above on Parivesh Portal.

State Govt. is requested to furnish the above information to this office for further processing of this proposal.
