**Subject:-** Proposal for diversion of 8.2222 ha. Forest land under section-2 of the Forest (Conservation) Act, 1980 for construction of coastal road from jalmarg sector-16 Kharghar to Sector-11 in CBD Belapur and Balance Link Transport Terminal in Nerul Mumbai in Thane and Raigad District in the State of Maharashtra (FP/MH/ROAD/153241/2022)

The Chief Conservator of Forests (T), Thane vide letter dated 10/06/2023 has submitted proposal for diversion of 8.2222 ha. Forest land under section-2 of the Forest (Conservation) Act, 1980 for construction of coastal road from jalmarg sector-16 Kharghar to Sector-11 in CBD Belapur and Balance Link Transport Terminal in Nerul Mumbai in Thane and Raigad District in the State of Maharashtra. During scrutiny of proposal, following discrepancies has been observed in the said proposal:-

- 1) The KML file not right properly, the said C.D is blank.
- 2) Diverted Area KML file not enclosed along with proposal.
- 3) C.A area KML file not enclosed along with proposal.
- 4) 3 alternative alignment KML file not enclosed along with proposal.
- 5) Copy of the CRZ clearance not enclosed along with proposal.
- 6) 7/12 extract of Survey/Gut No. 4/P, 6/4, 6/2, 145/C/P, 456/P, 470/P not enclosed vernacular language and English translated copy.
- 7) 7/12 extract of Proposed CA Survey No.283 Pt not enclosed vernacular language and English translated copy.
- 8) If Mitigation measure suggested your office the copy of the same to be submitted.

The above discrepancies should be complied at the earliest.
