Please refer to the subject and reference and it is to inform that the erstwhile Regional Office, Chennai vide letter dated 14.01.2019 requested the State Government to furnish certain additional information / documents and the same is yet to be received from the State Government. However, the PCCF (Head of Forest Force) (FAC), Govt. of Telangana vide letter no. 6985/2018-FCA1 dated 30.01.2021 submitted the additional information to the IRO, Hyderabad directly.

2 The additional information received from the PCCF (Head of Forest Force) (FAC), Govt. of Telangana has been scrutinized and found that, as per the KML file uploaded in the online application, it appears that the project works has already been started.

3 It is pertaining to inform you that the erstwhile Regional Office, Chennai requested the State Government several times to submit certain details in the prescribed proforma like, details of working permission issued, violation, status of compliance report etc pertaining to drinking water projects (under Mission Bhageeratha) and same is still awaited from the State Government.

4 Considering the above facts related to all drinking water proposals under Mission Bhageeratha and the subject proposal, I am herewith requesting you to submit detailed report in the prescribed proforma which was already been requested, along with the report on work in violation of FCA, 1980 under the subject proposal immediately for further necessary action please.
