S/Stn. Bhojraj to 132 KV/Stn. Arya Nagar & Lilo of one Line Circuit of 132 KV. D/C Sangwan to Khanak Line at 132KV S/Stn., Bhojraj Line on 132 KV D/C KKR Design Towers, under Forest Division and District Hisar & Bhiwani, Haryana.(Online Proposal No. FP/HR/Trans/50181/2020)

सन्दर्भ: i). प्रधान मुख्य वन संरक्षक के पत्र संख्या प्रशा डी तीन 10183/391 दिनांक 13.05.2022.

महोदय,

मुझे आपका ध्यान उपर्युक्त विषय से संदर्भित पत्र की ओर दिलाने का निर्देश हुआ है, जिसमें वन (संरक्षण) अधिनियम, 1980 की धारा- 2 के अनुसार गैर वानिकी उद्देश्य के लिए 0.5458 हेक्टेयर वन भूमि की मांग की गई है।

2. प्रस्ताव से सम्बंधित निम्नलिखित जानकारी भेजने का कष्ट करे:-

- Vegetation density in Bhiwani Forest Division is erroneous.
- In online part-II under column 4(ii) of Hisar Division, 53 trees of different species are uploaded as misc. species, needs to be uploaded for all species details with their scientific/local name.
- UA needs to upload whole alignment of the transmission line indicating the forest area as kml file for both divisions separately. At present, same kml files are uploaded as project site for both divisions.
- Detailed note on the project may be provided.
- Layout plan uploaded is not legible.
- Violation Report of IFA in Bhiwani Division needs to be uploaded.
- In online Part-II, under column 13(i) CA area for both plantation sites in Hisar Forest Division is uploaded as 2.08 ha. & compartment no is uploaded same for both sites, needs to be corrected.
- Clarification regarding total no. of trees to be felled in Hisar division, uploaded as 149 under Part-II 4(ii), whereas enumeration list of tree provided is of 242 trees.
- One of the pole/kml of transmission line i.e., TL-48 is also a part of proposed CA site named Siwani Feeder RD 184-211 L/Side. The Latitude/Longitude of pole/kml is 29.052262 75.751713 and 29.052551 75.751735. This needs to be clarified.
- Undertaking to submit FRA.
- As per DSS analysis, the total area for both CA sites has been given as 12.76 hectares out of which only 3.44 hectares is vacant for proposed CA plantation of 2080 plants. For management of point of view, KML file with proper coordinates for target plantation of 2080 plants may be provided.
