Sub: Proposal for diversion of 78.548 ha of forest land for laying of 132 KV S/C (on DC tower) transmission line from Seppa to Bameng under Comprehensive Scheme for strengthening of transmission & distribution system by Power Deptt. in East Kameng District of Arunachal Pradesh.

Sir,

In continuation to this office letter mentioned under reference (i) and (ii) above, I am to inform that the proposal mentioned under subject above has been discussed by REC in its meeting held on 20.04.2021 via video conference and the following has been sought:-

- (i) To clarify on the numbers of trees to be felled as it is mentioned as 1090 nos including poles in the forwarding letter whereas in the submitted enumeration list a total of 2430 nos has been observed (i.e. 514 nos of trees and 743 nos of poles as estimated in Seppa to Pachi and 576 nos of trees and 597 nos of poles in Pachi to Bameng).
- (ii) The scientific/local name of 154 nos. and 12 nos. of 'unknown' trees species as mentioned in the enumeration list from Seppa to Pachi and Pachi to Bameng respectively.
- (iii) To complete the uploading of the proposal on Parivesh portal as the same is pending in DFO level.

- (iv) State Govt comment/clarification on the proposed area as it is found to be **'INVIOATE'** due to the presence of Hydrological Layer as per the DSS report of FSI, Dehradun.
- (v) The mutation certification and preliminary notification for Kassing Putu (Ago) VFR Repari (Rakhe) VFR where an area of 88.10 and 69.00 ha respectively has been proposed for compensatory afforestation, if any.

State Govt is therefore requested to kindly furnish the above information at the earliest to this office for further necessary action.
