Attention of Divisional Forest Officer , Ananthapuramu is invited to the ref. 7<sup>th</sup> cited.

It is to inform that, the Gol, RO, Chennai vide ref. 7<sup>th</sup> cited (Copy enclosed) has requested to furnish the Compensatory Afforestation details like location of the degraded forest area identified along with map, DGPS coordinate and CA scheme etc. for further processing of the proposal.

In this regard, the Divisional Forest Officer , Ananthapuramu is requested to identify degraded forest land over an extent of 7.164 Ha (i.e. double the area of diverted forest land) and issue necessary instructions to the user agency to conduct DGPS survey on the degraded forest and submit the DGPS raw-data for its verification and authentication at the earliest. Further the CA Scheme shall also be prepared through CAMPA module online and submit to this office.

This should be treated as most urgent.
