- b) The process for initiating the action to exclude the overlapping of mining area with the area within the 600 m radius from the temple or as confirmed with the guidelines/notification from the ASI for exclusion of the mining activity, needs to be taken.
- c) As the revised area for mining is proposed to be of 18.989 ha the State recommendation on the same is also required. Further the revised CA, CA Scheme, NPV, Mining Plan, Kml files of the proposed area, safety zone area etc also is needed from the State Government.
