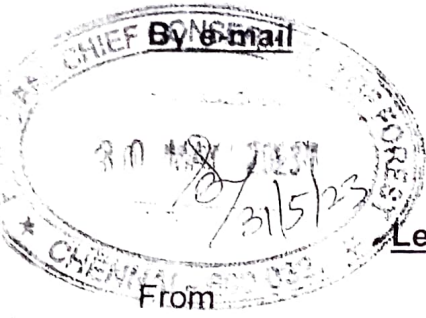

I am directed to invite attention to your letter first cited and to request you to clarify the following, for further consideration of the proposal :-

- i. As per Chapter 2 of Hand book of Forest (Conservation) Act, 1980, Compensatory Afforestation is one of the most important requirement for diversion of forest land for non-forest purposes. Hence, furnish the reason for non-submission of Compensatory Afforestation Scheme for the subject proposal.
- ii. In the subject proposal you have proposed a condition under S.No.(ix) that "If any maintenance work is under taken, the user agency shall seek written permission for the District Forest Officer". As per the Hand book of Forest (Conservation) Act, 1980 under Chapter J. Underground Gas / Water pipeline / OFC Project of PART C, no such condition is specified by the Government of India. Hence, indicate the reason for stipulating such a condition.

- iii. As the above project proposal is to be implemented in Kuruchi Forest block I and II Reserve lands and not along the Right of Way, mention the category (i.e., Chapter 4.2 or Chapter 4.3) under which the above said proposal is to be considered by Government.
