It is informed that proposals for diversion of forest area for formation of roads in LWE Districts have been sent to the Government for forwarding the same to GoI, MoEF&CC, for according necessary approval under FCA, 1980. In turn, the Government have forwarded the same to the GoI, MoEF&CC for approval.

In this regard, the GoI, MoEF&CC, IRO, Vijayawada, in the reference cited, has informed that on scrutiny of these proposals (Annexure-I), it is noted that provisions for Compensatory Aforestation as per the guidelines in vogue has not been made in the said proposals. In this connection, it may be noted that para 4.4 of the Comprehensive guidelines related to General approval for public infrastructure projects in LWE District has expired on 31.12.2020 and therefore, exemption of provision of CA for such projects is not applicable presently. It is requested that non forest area for compensatory aforestation may be identified and the details of the same may be submitted including map, DGPS co-ordinates, KML file, CA scheme, site suitability certificate etc., for further consideration of the proposals.
- 3. The Principal Chief Conservator of Forests & HoFF, is therefore requested to furnish the additional information to Government immediately for taking further necessary action in the matter, as desired by the GoI, MoEF&CC, IRO, Vijayawada in the reference cited.



In view of the above, it is to requested that suitable non forest area for compensatory afforestation may be identified and the details of the same may be submitted including map, DGPS co-ordinates, KML file, CA scheme, site suitability certificate etc. for further consideration of the proposals. These details shall also be uploaded in the online application.

Since these LWE districts proposals are being reviewed by the Ministry regularly, timely action under FCA, 1980 needs to be taken on these proposals. Hence, it is requested to submit above information at the earliest please.
