Subject: Construction of Entry & Exit for proposed retail outlet on Aligarh Mathura Road (SH 80) at 3.920 km on right lane in village Daultabad 0.04085 ha forest land in Aligarh District by Essar Oil Limited with felling of nil trees-reg.

Reference above mentioned subject matter; I have been directed to convey that following shortcomings have been found in the proposal:

- 1. As per details in Part I at A-1 (ix) requirement of non-forest land for the proposal is mentioned as NIL which is incorrect.
- 2. The period of diversion as mentioned in Part I at A1 (x) may be verified from the agreement document and the same needs correction.
- 3. The .kml file show proposed forest land diversion is tilted with respect to the alignment of the road.
- 4. The topo sheet showing location of proposed forest land diversion is without title, legend and index and the same has not been authenticated by the forest official.
- 5. The details regarding likely employment generation has not been filled by the user agency.
- 6. The uploaded land schedule has not been authenticated by the concerned DFO.
- 7. The site suitability certificate for compensatory afforestation is not as per prescribed format.
- 8. The .kml file for compensatory afforestation shows presence of large trees on Google earth and the same needs re-verification.
- 9. The compensatory afforestation scheme is for plantation of 100 saplings with RCC tree guard inside RF; the logic of plantation in RF with RCC tree guard is beyond comprehension. The estimate for compensatory afforestation and maintenance is on higher side.
- 10. Topo sheet showing location and boundary of compensatory afforestation is without title, legend and index.
- 11. The certificate issued by the DM under FRA 2006 is without affixing seal.

If required additional query may also be raised with the approval of competent authority. You are requested to submit the revised proposal with rectification of mistakes point wise. The proposal is returned in original for revision.
