Sir,

With subject and reference cited above, I am directed to inform that the State Govt. vide letter under reference has submitted the above mentioned proposal to this office seeking prior approval of Central Government under Section-2 of Forests (Conservation) Act, 1980. On examination of the proposal, it is observed that Stage-II forest clearance was granted in favour of NHAI (the primary user agency) for diversion of 174.1595 ha of forest land for 4/6 laning, widening & strengthening of NH-215 of Rimuli-Rajamunda Section and as per FC Act guidelines the NHAI has provided degraded forest land for raising compensatory afforestation as a Central PSU. In the instant proposal, the user agency i.e. M/s JSW Utkal Steel Ltd. (secondary user agency) has proposed for re-diversion of 2.990 ha of already diverted forest land in favour of NHAI.

Since, the secondary user agency is a private user agency; the special provision given to Central PSU for raising compensatory afforestation can not be given to a private agency. Hence, it is requested that equal non-forest land may be identified for raising compensatory afforestation for the instant diversion proposal.
