विषयः Diversion of 1.8272 ha. of forest land in favour of HPPWD for the construction of link road Chowk to Sandoa via Dharjol Ropri Dhar (Kms. 0/00 to 4/810), within the jurisdiction of Suket Forest Division, Distt. Mandi, Himachal Pradesh. (Online Proposal No. FP/HP/Road/40734/2019)

महोदय.

उपरोक्त विषय पर संदर्भित पत्र का आशय ग्रहण करते हुए सूचित करना है कि राज्य सरकार द्वारा विन्दु संख्या 4 एवं 5 में प्रस्तुत किये गए उत्तर पर और अधिक स्पष्टीकरण की आवश्यकता है । अतः राज्य सरकार चाही गई सूचनाओं के साथ-साथ निम्नलिखित बिन्दुओं पर अतिरिक्त सूचनाएँ भी प्रेषित करने का कष्ट करें, ताकि प्रस्ताव पर आगामी कार्यवाही सुनिश्चित की जा सके :-

- 1. Regarding point no 4 of EDS letter dated 28.9.2021 of this office, the State Govt. submitted that the Line Plan has been duly authenticated by competent authority, whereas the Line Plan has not been authenticated by competent authority i.e. concerned DFO. Therefore needful may be done.
- 2. Regarding point no 5 of EDS letter dated 28.9.2021 of this office, the State Govt. has submitted that...... - Justification/Clarification regarding the mismatching statement of violation mentioned in Para-6(b) of Site Inspection Report vis-vis Para-6 of Joint Inspection Report.
- ii. चूँिक सड़क उल्लंघन का मामला बर्ष 1980 से पूर्व का है, अतः Penal NPV की गणना को शून्य समझा जाए, राज्य सरकार दस्तावेजी साक्ष्यों सहित इस सम्बन्ध में अपनी टिप्पणी प्रस्तुत करें I
- iii. Documentary evidence/proof of existence of the road before the year 1980 as declaration made by the villagers of Dharjol and Sandoa mentioned at Sr. No. 2 of N.O.C/Affidavit dated 13.1.2022 may be provided.
 - 3. FRA Certificate has been submitted. However, proceedings of meeting of District Level Committee, Sub-Divisional Level Committee and a copy of records of all consultation

- and meetings of FRC and Gram Sabha of concerned villages may also be provided before Stage-II approval.
- Clarification regarding whether the CA land is a wasteland declared as PF under Notification of 1952 may be provided.
- 5. The copy of the revenue records viz Jamabandi of the area proposed for diversion under forest and non-forest land may be provided.
- 0.9049 ha non-forest/private land area has also been included in the proposed project.
 Therefore, copy of the sale deed/gift deed /affidavit made in the favour of HPPWD by owners of private land holders may be provided.
- 7. Muck Management Plan is not provided with the proposal. Therefore, MMP along-with muck generation calculation sheet, utilization details may also be submitted.
- 8. The KML clearly shows that the topography of the proposed site/ adjoining area is a hilly/sloping terrain. Hence, there is a strong possibility of soil erosion at the time of execution/after. Therefore, State Govt. may submit the Soil and Moisture Conservation Plan as per the latest guidelines issued by the Ministry letter dated 7.6.2022, if applicable.
- 9. An undertaking will be submitted by the concerned DFO in this effect that no plantation has been raised on proposed land for CA under any scheme in the past.
- 10. In the State Govt. forwarding letter dated 9.6.2022 it has been mentioned that the matter of violation on the proposal is before 1980. However, in the past letter dated 31.8.2022 it is mentioned that there is violation in the present proposal and said road is appearing at Sr. No. 32 of 5th Circle Palampur in the list of 2183 road proposal. Clarification may be provided in this regard.
- 11. State Govt. may upload the KML file of the proposed road in the tune of authenticated Line Plan on PARIVESH Portal.

State Govt. shall ensure that all the desired information/documents are uploaded on designated column in Part-I/II of PARIVESH Portal.
