Sub:- Proposal for diversion of 22.258 ha of balance forest land including 8.583 ha of Safety Zone as per Sabik settlement record as on 25.10.1980 in respect of Tailangi-A Chromite Mines in village Talangi & Ostapal in Sukinda Tahasil of Jajpur District of M/s IDCOL.

With reference to above cited memo on the captioned subject, it is to inform you that your recommendation to utilize 14.00 ha of excess non-forest land as CA for Tailangi-A mine out of 75.174 ha already declared as PF against Tailangi-B Chromite Mines can not be accepted. State Government has declared the above land as PF vide Notification No.10F (Cons) 43/2016-18734 dated 17.10.2017 and No.10F (Cons) 43/2016-18740 dated 17.10.2016 against diversion of forest land for Tailangi-B Chromite Mines, mentioning therein the Stage-I approval order No.8-97/2010-FC dated 02.02.2011 issued by MoEF & CC against Tailangi-B Chromite Mines.

Hence, you are requested to ask the User Agency to select another patch of non-forest land over 13.675 ha, get the alienation order, mutated RoR, GPS surveyed map and KML file for the above land for processing the proposal further.

The diversion proposal in quadruplicate is returned herewith for compliance and resubmission.
