

Sir,

I am directed to refer to State Government letter No.FEE39FLL2021 (e) dated 24.05.2021 on the subject mentioned above and to request to furnish the following clarification/information at the earliest;

1. It may be clarified that whether the proposed kuthca road is in existence prior to enactment Forest (Conservation) Act, 1980 and used by pilgrims to visit the temple, if so how the said road has been included in proposal for diversion of Wind Power Project in favour of M/s Suzlon Energy Limited.
2. Whether any FoC has been registered against any person/agency for illegal use of road in forest area.
3. Whether any alternate roads are available to the temple.
4. Recommendation of CCF Hassan dated 23.02.2021.
