On the basis of Rules/Guidelines framed under the Forest (Conservation) Act 1980 and subsequent Guidelines, communicated by Ministry in its Letter No.11-246/2014-FC dated the 3rd November, 2017, the above proposals has been accorded the **Stage-I (In-Principle) approval under General Approval of the Forest (Conservation) Act 1980**, by the State Govt. as the instant proposal falls within 100 km aerial distance from the Line of Actual Control (LAC). As the total area of forest land involved for diversion is 19.072 Ha & 7.838 Ha. It is not being able to upload the IPA on OMFC Portal from the level of the Nodal Officer (FCA), Govt. of Sikkim.

Therefore, it is requested to kindly upload the In-Principle Approval for the aforesaid proposals (copy of which is enclosed) for ready reference and necessary action.
