I am directed to refer to the State Government of Odisha's letter No. 10F (Cons.) 179/2015/16479/F&E dated 15.09.2015 on the above subject seeking prior approval of the Central Government under Section 2 (1) (ii) of the Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980 and to say that the proposal was considered by the Advisory Committee (AC) in its meeting held on 26.05.2025. The Advisory Committee, after going through the facts of the proposal decided to **defer** the proposal for want of the following information from the State Government:

- As the user agency i.e. Shri DC Jain is no more and the proposal for change in the name has been submitted by the UA through PARIVESH 2.0 portal, vide online id no. FP/OR/MIN/QRY/530182/2025, therefore it would be appropriate that the State Govt. shall first complete the process for approval of change in the name of the User Agency and resubmit the proposal thereafter.

In view of above, State Government is requested to resubmit the instant proposal after completing the process for approval of change in the name of the user agency as per recommendation of Advisory Committee.
