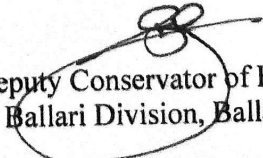

With reference to the above subject, the Government of Karnataka has sought additional information regarding diversion of 159.01 hectare of forest in Swamymalai Forest Block, Sandur South Range, Sandur Taluk, Ballari District in respect remaining forest area within Mining Lease ML No.1111 in favour of M/s. NMDC Limited, Donimalai vide letter under Ref(1). Accordingly, you have submitted information vide letter under Ref(5).

Upon verification of Part-I of Form-A of this proposal [which is submitted by you through Parivesh portal], the following observations are made.

- 1) As per your request letter dated : 11.03.2024, you have reduced the extent to 101.52 Ha from 159.01 Ha. This reduced extent (i.e.101.52 Ha) needs to be updated in Part-I of Form-A in Parivesh Portal.
- 2) It is observed in Point No. L(i), L(ii) & L(iii) of Part-I of Form-A, you have mentioned as 'Not applicable'. You are directed to indicate the CA land.
