Kindly refer to your online proposal No. FP/RJ/Road/41266/2019 dated 05.06.2023 recommended and forward the online proposal for seeking prior approval of the Central Government under the Forest (Conservation) Act, 1980. In this context, it is mentioned that as per MoEF&CC letter dated 15.05.2023 and Gazette Notification No. C.G.L.SA-03062023-246258 "Based on the recommendation of the Advisory Committee and approval of the same by the competent authority of the MoEF&CC, New Delhi, the central government hereby authorized officers of the rank of Divisional forest officer (DFO)/Deputy Conservator of Forests (DCF) and above of the State Government or union territory administration concerned, having jurisdiction over the forest land in respect of which any offense under the Forest (Conservation) Act,1980 is committed or violation of the provisions of the said Act has been made, to file complaints against such person/authority/organization, prima-facie found guilty of offence under the Act or the violation of the rules made thereunder, in the court having jurisdiction in the matter"
