"....... the proposal was considered in the 44th Meeting of Regional Empowered Committee (REC) held on 29-05-2020. REC noted that the width of the road is proposed to be increased to 45 mtrs which appears to be excessive as compared to the existing width, at least in forest area. Therefore, REC recommended that a revised proposal with considered reduced width in forest area may be submitted for consideration

incorporating provision for box culverts with prescribed dimension of safe movement of wildlife.

It is therefore instructed to transfer the FC web portal link to the User Agency through Deputy Conservator of Forests for taking further action as directed by Government of India.

FC web portal link will be transferred to you as and when received from the Government of Karnataka.
