Sir,

With the reference to the subject and reference cited above, it is to inform that, upon examination of the non-forest area identified for CA purpose, it is noticed that, the identified area is appears to be a VDF / MDF and it may not possible to carryout plantation of required Number of plants i.e 1000 trees / ha. It is also noticed that, to carryout required number of plantation, no such degraded forest area has been proposed. Further, it is to bring to your notice that, DFO uploaded CA scheme with financial outlay of **Rs 100 lakhs** under PART II of the online proposal. Whereas, the State Government reported that CA scheme with a financial outlay of **Rs.67.078 lakh** for a period of 12 years including advance operations, maintenance of nurseries and raising of plantations;

In view of the above, it is requested to re-examine the above issues and submit the following information/clarifications;

(i) Whether identified area (claimed to be non-forest area) attracts provisions of FCA, 1980 or otherwise. Actual legal status of the area in the government record may also be informed along with the supporting documents;

- (ii) DFO may please be instructed to carryout inspection of the area identified for CA purpose once again to ascertain the actual numbers of trees that can be taken up for planting in the identified area and in case it is not possible to carryout required number of plantation in the identified non forest area i.e. 1000 trees/ ha, the remaining number of plants will be required to be raised in the degraded forest area. Hence, suitable DFL area may be identified and details of such DFL area may please be furnished.
- (iii) CA scheme may please be revised accordingly and submitted;

The above information may be furnished to this office at the earliest for further consideration of the proposal under FCA, 1980.
