1. In query no.2 Central Government sought "specific recommendation / comments from PCCF (Wildlife) Maharashtra on the importance of area from wildlife point of view and conservation measures, if any shall be submitted" where Chief Conservator of Forests (T), Chandrapur submitted that "The area has resident Tiger in Compt. No 552, adjacent to the proposed area", which does not fulfill the information sought.

Deputy Conservator of Forests, Central Chanda, Chandrapur shall submit the justification of query keeping in view the guidelines issued by this office on dated 19/05/2025 (copy enclosed).

2. A revised site specific scheme of CA shall be submitted with current wage rate.
