Sir,

Kindly refer to the online proposal of Government of Jammu & Kashmir on the above-mentioned subject seeking prior approval of the Central Government for diversion of 4 ha of forest land in **Sindh forest division** for non-forestry purpose in accordance with section-2 of the Forest (Conservation) Act, 1980.

2. After careful examination of the above-mentioned proposal of the Govt of J&K, the following information/clarification area still required to be submitted:

- i) As per justification letter submitted online at D(i) of part I, the forest land to be diverted is 2.4 ha, while the actual area submitted by UA is 4 ha. Justification letter may be revised and resubmitted.
 - ii) CA plan is not approved by the competent authority. Duly approved CA plan from concerned authority may be submitted.
 - iii) Since, there are presence of wildlife around project site, such as Common Leopard, Himalayan Black Bear, Jackal etc; hence, comments from the CWLW may be submitted.
 - iv) Revised DGPS map of project site needs to be submitted as one reading of latitude/longitude is missing.
 - v) DGPS Map of the CA site needs to be submitted/uploaded as currently Google map is uploaded.
 - vi) Revised specific recommendation from the DFO as per format of part II needs to be submitted.
3. The compliance to the above may be submitted within 30 days from the date of issue of this letter failing which the proposal shall be liable to be rejected for want to information.
