Kindly refer to the subject cited above. I am directed to inform that after the site inspection carried out by the Additional PCCF (C) on 18.06.2016, the following observations are made: -

- (1) The user agency has proposed the new alignment instead of widening the existing road, which would have minimized the felling of large number of trees. The detailed justification for the same along with the data maintained by R&B Department on the density of the vehicles on this road.
- (2) Whether the Forest Department agree for translocation of trees depending on the feasibility, atleast certain number, if user agency is willing to pay the cost for the same.


