विषय: Diversion of 0.5853 ha. of forest land for Laying of RCC NP2 Pipeline of 1000mm dia in the length of 9000 feet along Habri to Sirsal road, Right side in Habri under forest division and District Kaithal, Haryana. (Online Proposal No. FP/HR/Pipeline/148416/2021)

महोदय,

मुझे आपका ध्यान उपर्युक्त विषय से संदर्भित पत्र की ओर दिलाने का निर्देश हुआ है, जिसमें वन (संरक्षण) अधिनियम, 1980 की धारा- 2 के अनुसार गैर वानिकी उद्देश्य के लिए 0.5853 हेक्टेयर वन भूमि की मांग की गई है।
 2. प्रस्ताव से सम्बंधित निम्नलिखित जानकारी भेजने का कष्ट करे:-

- The pipeline passes through villages such as Sirsal to Habri, whereas village-wise break up of the forest land is uploaded only for village Habri. Hence, village-wise break-up of all villages need to be updated.
- Temporary employment (in person days) is uploaded as 15 for 9000 feet long pipeline construction. Realistic figure may be updated.
- In online Part-II, under column 4(ii), 30 no of trees are uploaded as miscellaneous species and needs to be uploaded for all species along with their scientific name & local name.
- In online Part-II, under column 4(i), vegetation density is uploaded as 0.4, whereas the NPV is taken as very dense forest instead of dense forest. Hence, separate NPV calculation sheet needs to be submitted as per given vegetation density and eco-class.
- Revised DGPS map needs to be uploaded, because, currently, it is uploaded without latitude/longitude readings under column 13 (iii) Part 2.
- Approval of the project by competent authority needs to be submitted.
- Under layout plan, there is provision for construction of pump house over the forest land. Hence, duly approved layout plan for the proposed pipe line as well as pump house with component wise/Dimension wise area details needs to be submitted.
- Rationalization of the barbed wire fencing in CA scheme. The State Government was requested many times since December, 2021 to rationalize overall CA scheme, but it has not been done yet. Hence, the CA scheme needs to be revised with rationalized fencing charges, which is almost 50% of total CA charges.
