The Officers noted in the address entry are informed that the GoI, MoEF&CC, RO (SEZ), Chennai vide reference 3<sup>rd</sup> cited (copy enclosed) has furnished the minutes of the 50<sup>th</sup> REC meeting held on 21-9-2021 at 10.30 AM through VC. In the Minutes of the meeting the Committee after detailed deliberation has given the recommendations of REC on each proposal are as detailed below:

<b>Agenda No.1:</b>	Diversion of 5.890 ha (2.5384 ha in Echoda and 3.3516 ha in UtnoorFDPT) of forest land for upgradation of existing road to Neradigonda Mandal Nagamalia RF of Utnoor FDPT & Echoda Divisions of Adilabad District in favour of Dist. PR Engineer, Adilabad.

**Recommendation:** *Recommended the proposal subject to Standard conditions for such road projects along with the following additional conditions.*

1. Considering violations of FCA, 1980, action to be taken on User Agency/Forest Department officials are as follows;
2. For works carried out in violation of FCA, 1980 by the UA over an extent of 1.32 ha, the State Government shall realize penalty (penal NPV) of 2 times of NPV plus 12 percent simple interest till the deposit is made for area of 1.32 ha as per provisions made in the comprehensive hand book under section 1.21 (ii) (a) and (b);
3. The violation committed by the User Agency/Forest Department officials shall be dealt as per provisions made in the comprehensive hand book under section 1.21(ii)(c) and (d) by the State Government;
4. Proposed Penal CA of 3.0 ha (i.e. double the extent of violation) over degraded forest land shall be carried out at the cost of the User Agency;
5. Wildlife mitigation measures plan shall be prepared and implemented by the State Forest Department at the cost of the User Agency;
