संदर्भ/Reference: The State Government letter No 3942/For.I(1)/2022 dated 16.01.2023 and online proposal No. FP/TG/TRANS/155854/2022

महोदया/Madam,

With reference to the subject and reference cited above, I am directed to inform that the proposal was examined in the Integrated Regional Office and noticed certain deficiencies. Therefore, it is requested to submit the following additional information/clarification at the earliest to this office for further processing of the proposal. The RoFR needs to be settled and a document in support of it should be submitted by the SFD.

- The DFO in his report stated that, as informed by the UA, the old electricity line is existing prior to 1980. Documents in support of the same need to be furnished by the UA/SFD.
- The RoFR needs to be settled and a document in support of it should be submitted by the SFD.
- In the online, under Part-II, the DFO mentioned the forest as Eco Class 3. However, in the site inspection report, it is reported as Eco Class II. It needs to be verified and correct status informed. In future, such ambiguous reporting should be avoided.

- iv. As per the SIR uploaded by DFO, part of the forest area proposed for diversion is falling in the ESZ of Kinnersani WL Sanctuary. However, the same has not been mentioned in Part II of the online proposal but mentioned by UA in Part-I. As the proposal falls in the ESZ, clearance is required from the competent authority. Kindly update the details of online proposal at relevant places and submit the inspection reports along with photographs.
- v. The DFO proposed CA over DFL area. As proposal is accepted by the Nodal officer after 28.06.2022 (as per the timeline on Parivesh), the subject proposal needs to be processed as per the F(C) Rule 2022. Accordingly, the UA shall provide equivalent NFL for CA purpose. The SFD need to submit the revised CA scheme.
