Sir,

Kindly refer to the online proposal of Government of Jammu & Kashmir on the above-mentioned subject seeking prior approval of the Central Government for diversion of **8.233125** ha of forest land for non-forestry purpose in accordance with section-2 of the Forest (Conservation) Act, 1980.

2. After careful examination of the above-mentioned proposal of the Government of J&K in the 40th meeting of REC, the following information/clarifications are still required to be submitted before Stage-I approval is granted:

- (i) The extent of area proposed for diversion in this proposal and in future proposals to be restricted to four places after decimal.
- (ii) Uniformity in the extent of area proposed for diversion to be made in the proposal from 8.23 ha to 8.2331 ha in this proposal.
- (iii) CA estimate to be revised from 8.23 ha to 8.2331 ha
- (iv) Revised KML file of CA site to be uploaded online.

3. The compliance to the above may be submitted within 30 days from the date of issue of this letter failing which the proposal shall be liable to be rejected for want of information.
