Sir,

Please refer to the Government of Mizoram letter G.20015 /3/2019 -FST dated 28.03.2022 on the subject mentioned above, seeking prior approval of the Central Government in accordance with Section 2 of the FCA, 1980. The proposal forwarded by the State Govt has been examined in this office in the light of Forest (Conservation) Act, 1980, and rules/guidelines framed thereunder. The State Govt. is requested to provide following additional information for further processing of the case:

- (1) The chronology of events on the violation of FC Act, 1980.
- (2) The State Govt may submit a self-contained report of final action on the violation of FC Act, 1980 and action as per Ministry's letter dated 29/1/2018 as mentioned by it.
- (3) Whether the work has been completed and the area of violation may be specified.
- (4) NPV is to be calculated as per revised rate dated 06.01.2022 & 19.01.2022.
- (5) Compensatory Afforestation Scheme submitted has not been technically approved by Competent Authority. State Govt may re-submit with technical approval.
- (6) Dwarf plantation Scheme has not been submitted. The same to be prepared and approved by competent authority.
- (7) Total length of Tr. line with Right of Way.
- (8) Whether any alternatives have been explored for the transmission line, if yes the 3 routes to be shown on map to be duly signed and authenticated by DFO concerned.
- (9) 3-dimensional sketch of the transmission line showing dimensions of tower along with its foot-prints.
- (10) The distance of the proposed diversion site from the nearest Protected Area.
- (11) Forest Right Act certificate.
- (12) Undertaking for compensatory afforestation and tree felling from the user agency.
- (13) GPS- Coordinated for the proposed diversion area and CA site.
