Subject: Proposal for seeking prior approval of the Central Government under section 2 (1) (ii) of the Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980 for non-forestry use of 0.7984 ha of forest land in favour of Sh. Vinod Kumar, S/o Swami Ram for extraction of sand, stone and bajri in Son Khad Part-II at Kalswai, Village- Trambala, P.O. Longni, Tehsil Dharampur, District Mandi in the State of Himachal Pradesh (Online Proposal No. FP/HP/MIN/129370/2021)- regarding.

Sir,

I am directed to refer to the Government of Himachal Pradesh online proposal no. FP/HP/MIN/129370/2021 dated 28.02.2023 on the above mentioned subject seeking prior approval of the Central Government under Section- 2 (i) (ii) of the Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980.

2. In this regard, it is to inform that the proposal was discussed in the Advisory Committee (AC) in its meeting held on 07.06.2024. The detailed minutes of the said AC meeting are uploaded at www.parivesh.nic.in. The Committee had detailed discussion and deliberation with the DDGF (Central), RO Chandigarh, Conservator of Forests, Government of Himachal Pradesh. The Committee recommended the proposal for grant of Stage- I clearance for diversion of 0.7984 ha. of forest land for mining lease for extraction of Sand, Stone and Bajri in Son Khad Part-II at Kalsawai, within the jurisdiction of Joginder Nagar Forest Division, District Mandi, HP.

Furthermore, the Committee stated that Stage-I approval for the proposal, shall be considered provided that the State Government submit the following:

- i. The State Government shall identify middle of the riverbed, demarcate safety zone and submit KML file to the Ministry.
- ii. Copy of Chej Khobla DPF Notification No. Fts (F) 5- 1/80 dt. 18.08.1980.

In view of the above the State Govt. is requested to submit the information, as indicated above, to this Ministry for further consideration of the proposal.
