A copy of the reference 9th cited is enclosed herewith, wherein the Integrated Regional Office, MoEF&CC, GoI, Hyderabad has called for certain additional information as detailed below, on the subject proposal:

- i. The User Agency has not filled up the details of earlier proposals submitted in the past under FCA, 1980 in the relevant column of the parivesh portal. Hence User Agency may be directed to fill mandatory information under PART I.
- ii. On perusal of the available Google images, it is noticed that in 10/2007 cart tract of less than 3.50 mtr was present but it was widened to 7.00 mtr in the period between 10/2007 to 03/2011. Further, it was noticed around 03/2022, BT road was laid for a length of about 54 mtr. Hence, the State Government may kindly furnish the details of works carried out, if any by the User Agency in violation of FCA, 1980.
- iii. Majority of the alignment is passing through agricultural fields, however, comments regarding the current vegetation status, encroachments/RoFR pattas, if any, issued

- iv. The proposed road is going to benefit about 350 tribal population only and the area is falling within the Kawal Tiger Reserve, SFD has not submitted any report on the possible adverse impacts of the project on the WL in general and the Tiger habitat in specific. Hence, detailed not on the above matter shall be submitted by the SFD.
- v. Cross section and nature of road proposed to be constructed is not furnished. The same shall be submitted by the User Agency.
- vi. As per the Topo map of the proposed diversion, the eastern end of the proposed diversion falls outside RF. Further, in the toposheet, there is an existing road. However, the proposed diversion does not follow the road seen in the topo map. Alternatives examined to the current proposal may be furnished by the UA and the SFD.
- vii. CA land identified is found to be located near to the human settlement/ Further, on superimposing the CA map on the topo sheet, it was seen that identified CA overlaps with the Reserve Forest. Hence the legal status of the non-forest area identified for CA purposes shall be examined and a report on the same may be submitted.
- viii. Kml uploaded for the CA land is for 1.21 Ha & CA topo map uploaded is of 2.685 ha. Further, the map is not countersigned by the DFO. Correct Kml shall be uploaded on Parivesh & CA map submitted shall be countersigned by the District Forest Officer..
- ix. In FDO report, it is mentioned that CA land is rocky with Murram soil. Hence, FDO proposed for DFL in Maskapur RF. In view of a lot of encroachments noticed around the forest area proposed for diversion, the CA may be undertaken near the proposed road diversion by evicting the encroachments.
- x. FDO in his soil suitability certificate mentioned that Chain Link fencing should be there for protection of the CA land. However, on perusal of the CA scheme, it was noticed that no chain link fencing for the CA land has been proposed. The same may be rectified.
- xi. In part-II (Online) details of vegetation has not been filled by the DFO.
- xii. DFO reported that proposed road is passing along the cart track and there is a chance of erosion due to the upgradation of road. Hence a suitable mitigation plan may be submitted;
- xiii. Site Inspection Report (SIR) of the proposed diversion carried out by the FDO instead of DFO is enclosed. It is recommended for 6 animal passages at one place and 4 animal passages at other place. Hence, a site inspection report by the DFO concerned may be submitted clearly indicting the status of land, vegetation cover, proof of existing road/cart track as per RF notification, impact of the road of adjoining forest, Wildlife and its habitat etc.

In view of above, the District Forest Officer, Nirmal is requested to submit information / details on above **Point**, duly obtaining information / details as required from the concerned User Agency and submit the same to this office for taking further necessary action in the matter.

The above information should reach in a complete shape by 28.05.2023 without waiting for any further reminders.
