- iv. Village wise breakup and component wise breakup in column B-2.3 and component wise breakup in B-2.4 of part I is not mentioned.
- v. Toposheet uploaded in c (iii) is not matching with KML file of the project site.
- vi. DGPS map of proposed site is not correct.
- vii. Original hard copy of FRA certification and the same be uploaded as additional document in part I online
- viii. Density in column 4 (I) is not matching with the column 7 (vi) part II form A submitted by DFO.
- ix. Column 13 (ii) (iv) is not correct.
- x. The geo referenced digital map of the proposed road at column C (iv) of part I is not uploaded. Correct map be uploaded and hard copy of original map signed by DFO be provided.
- xi. The geo referenced digital map of the area proposed for CA uploaded online at column 13 (ii) of Part II is not uploaded. Correct DGPS map of CA be uploaded giving geo-coordinates at all corner points in shape file alongwith hard copy of original digital map signed by DFO.
