It is informed that, in the reference 1st cited (copy enclosed), the Government of Andhra Pradesh have stated that, as per 4.4 of Chapter-4 of comprehensive guidelines issued by Gol, MoEF &CC, New Delhi in F. no. 5-2/2017-FC, dated: 28.03.2019 related to General approval for public infrastructure projects in LWE Districts has expired on 31.12.2020 and therefore, exemption of provision of CA for such projects is not applicable presently. It is requested that non-forest area for compensatory afforestation may be identified and the details of the same may be submitted including map, DGPS co-ordinates, KML file, CA scheme, site suitability certificate etc., for further consideration of the proposals.

Further, in the reference 2nd cited (copy enclosed), the Government of India, MoEF &CC, New Delhi have clarified that the existing guidelines at paras 4.4 and 4.5 of Chapter-4 of comprehensive guidelines issued by Gol, MoEF &CC, New Delhi in F. no. 5-2/2017-FC, dated: 28.03.2019 , are hereby withdrawn.

In this regard, the Conservator of Forests, Visakhapatnam is requested to issue necessary directions to the concerned Executive Engineers of Panchayat Raj Department to identify non-forest land for CA and submit the same including map, DGPS co-ordinates, KML file, CA scheme, site suitability certificate etc., for further consideration of the following proposals.
