


Sub: Proposal for diversion of forest land for Construction of link road from Beer Bagh to Kanhal via Shiva in Social Forestry Division Doda.

Ref: Proposal No. FP/JK/Road/146385/2021.

This is with reference to the above proposal. The Conservator of Forests, Chenab Circle Doda/DFO Social Forestry Division Doda/User Agency are requested to upload the following documents within two days:-

1. Under column B-2.3 in Part-I, the village break of forest and non-forest land has not been given. The detail of forest and non-forest land need to be filled by user agency under column B-2.3.
2. In Part-II, the name of the forest for CA site, need to be given under column 13 by DFO S.F. Doda.
3. Enumeration list of trees have been prepared dia-class wise instead of girth-wise. The revised enumeration list of trees need to be uploaded and accordingly detail of trees need be uploaded under column 4(ii) in Part-II.
4. One number of dumping site in forest area has been proposed. The proposal for stabilization (biological measure) of muck dumping site need to be prepared and uploaded by the DFO S.F. Doda.
5. Compensation of trees has been assessed and uploaded in Part-II. The compensation of trees is not applicable under the provisions of Forest (Conservation) Act, 1980.
6. Revised NPV rates issued by the MoEF&CC vide communication dated 06-01-2022 are applicable w.e.f. 07-01-2022, whereas NPV has been assessed for old rates. NPV needs to be assessed as per new rates of NPV by the DFO S.F. Doda.
7. Specific recommendation as per format of Part II (page no 22-24 of Handbook of forest (Conservation) Act, 1980 and Forest conservation Rules, 2003 (Guidelines & Clarification), 2019 MoEF&CC; at SN. 16 of online part-II need to be uploaded by DFO S.F. Doda.
