**Sub: Diversion of 0.5705 ha. of forest land (instead of 0.5948 ha.) in favour of Snowfoam Energy Pvt. Ltd for the construction of Hamsu-I SHEP (2 MW), within the jurisdiction of Kullu Forest Division, Distt. Kullu, H.P. (Online Proposal No. FP/HP/HYD/39463/2019).**

महोदय,

उपरोक्त संदर्भित पत्र द्वारा प्रस्तुत प्रतिउत्तर का ध्यानापूर्वक अवलोकन करने के पश्चात अभी भी निम्नलिखित कमियां पाई गई हैं:-

1. A list of proposals approved/existing has been furnished in map. However, approved capacity of the river/rivulet and a comprehensive list of projects in the landscape mentioning/showing generation capacity, execution/transmission plan, distance of each project from nearest Protected Area (PA) and its notified ESZ along with their impacts is required to be submitted. Also, the revised KML file needs to be submitted and uploaded on the PARIVESH Portal.
2. The progressive detail/status of area treated and funds utilized as on date under comprehensive CAT Plan for Beas Basin is required to be submitted.
3. The FRA Certificate has been provided, however proceeding of consultaions and meetings with Gram Sabha(s) and FRC(s) of concerned villages are not provided. The same may be provided.
4. As per DSS analysis, proposed diversion area is having Very Dense Forest category in more than 01 sq. Km area. Therefore, the State Govt. may review the same and comments in this regard may be submitted. If required, density class and NPV calculation sheet may be revised accordingly.

Further, this may be ensured that proposal may be thoroughly scrutinized, reviewed and revised keeping in mind the suggestions given by the MoEF&CC, New Delhi vide File no. 8B/HP/01/147/2019/FC, OM dated 13.05.2022 regarding the Hydel projects of Himachal Pradesh. The compliance of above observations is required to be uploaded in PARIVESH portal at designated locations.

**You are, therefore requested to kindly ensure to submit the reply to IRO, Shimla only after satisfactory compliance of all the observation/shortcomings as mentioned above.**
