Sub: Diversion of 16.2635 ha of forest land for construction of 220 KV D/C Govindpur to Dumka Transmission Line in favour of JUSNL.

Sir,

I am directed to refer to your letter No. Van Bhumi-8/2017-2515/Va.Pa. dated 15.6.2017 on the above mentioned subject and to inform that the proposal has been scrutinized and it is observed that following documents/ information have not been furnished with the proposal:

- i. Details of the area calculation (length x width) of forest land proposed for diversion under all the three Forest Division.
- ii. A certificate of concerned DFO stating that survey numbers of the non-forest land involved in construction of proposed road does not fall under the category of deemed forests or otherwise where provisions of Forest (Conservation) Act, 1980 are applicable.
- iii. Part-I may be signed either by JUSNL or PGCIL for JUSNL and submitted in original with mentioning the date of sign.
- iv. Part-II of Dumka Forest Division with mentioning the name of the signing authority along with date.
- v. Part-IV in original.
- vi. Action taken report on erring officials for the work in violation of F(C) Act 1980.
- vii. Toposheet map and geo-referenced map of the forest area identified for CA under Jamtara & Dumka FD.
- viii. CA scheme with minimum 7 years maintenance under Dumka FD.
- ix. Original FRA certificates of all the four divisions along with documents regarding consultations/ proceeding of Sub-Divisional Level Committee and District Level Committee of Deoghar FD and consultations/ proceeding of Sub-Divisional Level Committee of Dumka FD & Dhanbad FD. Garm Sabha resolutions of all the villages under Deoghar FD.
- x. In Dumka FD, FRA certificate involving area of 2.27 ha f deemed forest in Ministry's prescribed format as applicable for linear proposal.
- xi. Geo-referenced map of the total alignment of the transmission line depicting forest land proposed for diversion.
- xii. Geo-referenced map of the other alternate routes depicting forest land involved in the routes.

Therefore, it is requested that the aforementioned documents/ clarifications may be submitted to this office for further processing of the proposal.
