In light of the directions issued by the Principal Chief Conservator of Forests (Forest Conservation), Bengaluru, in his letter (3) cited above and followed by the letter of the Government of India, Ministry of Environment, Forests & Climate Integrated Regional Office, Bengaluru, and Government of Karnataka vide their letter (1) and (2) respectively cited above, has directed to submit the information/ clarification on the following points.

- The document in support of the directions from the Archaeological Survey of India with respect to the temple being an Archaeological site and the prescribed distance from the site within which the mining activity is not permissible is required.
- 2) The process for initiating the action to exclude the overlapping of mining area with the area within the 600m radius from the temple or as confirmed with the guidelines/ notification from Archaeological Survey of India (ASI) for exclusion of the mining activity, needs to be taken.
- 3) As the revised area for mining is proposed to be of 18.989 ha the State recommendation on the same is also required. Further, the revised CA, CA Scheme, NPV, Mining Plan, KML files of the proposed area, safety zone area etc., also is needed.

Therefore, you are hereby directed to go through the points as raised therein and furnish the additional information/ clarification duly obtaining the same from the user agency for onward submission of the same to the higher authorities for taking further necessary action in the matter.
