

Sub: Proposal for diversion of 7.7664 ha of forest land for construction of 320 M span Major Permanent Bridge over Lohit River at 14.50 Km (Tinai) on Karoti Tinai to Dichu road by BRTF in Anjaw District of Arunachal Pradesh.

Please refer to the online proposal No. FP/AR/ROAD/74913/2020 submitted by State Govt seeking prior approval of the Central Government in accordance with Section 2 (1) of the Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980, I am directed to inform that the proposal has been examined in this office in the light of Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980 and rules/guidelines framed thereunder and following lacking information are observed:-

- (i) A brief details on the remaining stretch of the road.
- (ii) To clarify whether the 15 nos. of employee is to be recruited permanently for this specific project in BRTF or not, and total numbers of employee/temporary employee to be provided in mandays.
- (iii) The 3 alternate route examinations indicating on SoI toposheet.
- (iv) Justification for choosing this proposed route from the other two alternatives mentioning ecological parameters i.e. forest cover, forest type, habitation etc.
- (v) The Muck disposal plan, approved and authenticated by the concerned DFO.
- (vi) To clarify on the identified CA site as the location recommended by the CCF in Part II is observed to be different from the detail mentioned in the State Govt forwarding letter.
- (vii) The site suitability certificate of the identified CA site.
- (viii) The CA scheme authenticated and signed by the competent authority.
- (ix) The soft copy of the kml file of the identified CA site.

- (x) The SoI map indicating the identified CA site with GPS coordinates authenticated by the concerned DFO.
- (xi)The copy of the PSC minutes as it is mandatory to submit as per Ministry's guideline dated 25.01.2024.
- (xii) State Govt to comment on the forest clearance status of the settlement area, agricultural land and exiting road within the proposed diversion area as observed in google imagery 2023.
- (xiii) The aerial distance of the proposed area from nearest boundary of P.A./WLS/NP.

State Govt. is requested to furnish the above information to this office at the earliest for further processing of the proposal.
